DYLAN AGIUS, 23 years, barman, son of Ronald and Michelina nee' Galea, born in Pieta' on the 2nd September, 1987 and residing at Binja F. Sciberras, Ent. B, Fl2, Triq Pietro Floriani, Floriana and holder of Identity Card number 401187(M); and

ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Dylan Agius** and prohibits the said accused from transferring or otherwise disposing of any moveable or immovable property and this according to Section 22A(1)(a)(b) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A(2) of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused can continue to receive his salary, wage, pension and social benefits which amount will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents ((€13,976.24) yearly.
