

IT IS BEING NOTIFIED that by a decree given by the Court of Magistrates (Malta), as a Court of Criminal Judicature, (Magistrate Dr. Miriam Hayman LLD), on the 15th of October, 2010 the Court acceded to the request made by Laurence Seychell in Compilation number 1096/2006 in the names;

LAURENCE SEYCHELL, 54 years, Bank employee, son of Thomas and Mary nee' Grech, born in Pieta' on the 6th of August, 1956 and residing at Number 13, 'Is-Sienja', Triq il-Luqqata, Kalkara and holder of Identity card No.549256 (M);

AUTHORISED the Bank of Valletta plc to release the sum of four hundred Euros (€400) from his current wage, which sum must be deposited or transferred in the House loan account number 400 1473 3417 and this only to satisfy the home loan which bears the name of Laurence Seychell and that of his wife Salvina Seychell.

The publication of this order is being published in terms of the Article 5(1) of Chapter 373 of the Laws of Malta, following another publication made on the 26th April, 2007 after a decree given by the same Court on the 25th April, 2007 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other moveable and immoveable property which may be due to or belonging to **Laurence Seychell**.
