

IT IS BEING NOTIFIED that by a decree dated 12th July, 2012, given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dott. Neville Camilleri LLD) Compilation number 349/2012 in the case:

Versus:

VINCENT CUCCIARDI, 35 years, employee, son of Angelo and Anna nee' Cutajar, born in Pieta' on the 2nd February, 1977 and residing at Flat No. 6, 'Gardenia Flats', Triq il-Gnien, Msida and holder of Maltese Identity card bearing number 112877 (M).

ORDERED the attachment in the hands of third parties in general all moneys and other movable property due or pertaining or belonging **Vincent Cucciardi** prohibited them from transferring or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the accused may continue to receive an amount not exceeding thirteen thousand, nine hundred and seventy six Euro and twenty-four Euro cents (€13,976.24) per year. This amount is not included in the attachment order.
