

**IT IS BEING NOTIFIED** that by a decree dated 24<sup>th</sup> March, 2011 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dott. Antonio Micallef Trigona) Compilation Number 1311/2010 in the case:

Versus:

**DAVID GATT**, 41 years, lawyer, son of Joseph and Helen nee' Abela, born in Attard on the 31<sup>st</sup> of January, 1970 and residing at 25, 'Casa Gatt', Triq Karm Zerafa, Birkirkara holder of Identity card No.74670(M).

**AFTER** the freezing order of the 8<sup>th</sup> February, 2011 that was published in the Government Gazette on the 15<sup>th</sup> February, 2011, the Court after having seen the application submitted by David Gatt where he humbly requested to:

- 1) Authorize him to encash the pension cheques he receives from the Treasury, with effect from the month of November, 2010, and the money due to him in connection with the case in the names *David Gatt vs Prime Minister et.*
- 2) Authorize him to continue to receive any credit due to him which in total does not exceed the amount of thirteen thousand, nine hundred seventy six Euros (€13,976) every year according to Article 5(1) of Chapter 373 of the Laws of Malta.

The Court upheld the two requests in accordance with the proviso of Article 5 (1) of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A of the Criminal Code, provided that the amount received does not exceed the amount of thirteen thousand, nine hundred seventy six Euros (€13,976) per year.
