HERMAN MC KAY, 28 years, self-employed, son of Martin and Maria Dolores nee' Mifsud, born in Pieta' on the 24th November, 1983 and residing at 275, Triq Hal-Qormi, Marsa or at 100, Triq il-Kbira, Qormi and holder of a Identity card No.590483(M).

ORDERED the attachment in the hands of third parties in general all moneys and other movable property due or pertaining or belonging to **Herman Mc Kay** and prohibited him from transferring or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said **Herman Mc Kay** can continue to receive his salary, wage, pension and social benefits which amount will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
