ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Jomic Calleja** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said **Jomic Calleja** can continue to receive the amount not exceeding thirteen thousand, nine hundred and seventy six Euro ((€13,976.00)).
