THOMAS JOHN WOODS, 61 years, pensioner, son of Thomas John and Josephine nee' Mallia, born in Bedford, England on the 10th April, 1949 and residing at 'Villino Estero', Triq Valletta, Mosta and holder of Identity Card number 385387(M);

ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Thomas John Woods** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A (2) and 23B of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court authorized **Thomas John Woods** to receive yearly the amount which does not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24).
