**KEITH CAMILLERI**, 28 years, unemployed, son of Fabian and Giacinta nee' Azzopardi, born in Pieta' on the 25<sup>th</sup> August, 1981 and residing at 16, Redeemer, Triq Karmenu Camilleri, Qormi and holder of Identity Card number 481481(M);

**ORDERED** the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Keith Camilleri** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A(2) of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said **Keith Camilleri** can continue to receive his salary or social benefits which amount will not exceed thirteen thousand, nine hundred and seventy six Euro ((€13,976.00).
