ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Giuseppe Cutajar and Sharon Camilleri** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive their salary and social benefits which amount will not exceed thirteen thousand, nine hundred and seventy six Euro (€13,976.00) per year.
