

IT IS BEING NOTIFIED that by a decree dated 8th May, 2010, given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dott. Consuelo Scerri Herrera LL.D.) Compilation Number 456/2010 in the case:

ANTHONY DEBATTISTA, 63 years, pensioner, son of John and Antonia nee' Calleja, born in Msida on the 13th February, 1947 and residing at White Arrow Garage, Clarence Street, Msida and holder of Identity card No.193147(M).

ORDERED the attachment in the hands of third parties in general all moneys and other movable property due or pertaining or belonging to **Anthony Debattista** and prohibited him from transferring or otherwise disposing of any movable or immovable property and this according to Section 22A(1)(a)(b) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta.

This order is being given without prejudice to the pension that **Anthony Debattista** receives from the Director of the Social Security and which is credited in the HSBC account, thus the monthly deposit will not effected by this order.

The Court is also authorising the said **Anthony Debattista** that once a year, as provided by Law, withdraws the sum which must not exceed thirteen thousand, nine hundred and seventy six Euro and 24 cents ((€13,976.24) for his living.
