ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Alexander Scudamore** and prohibits the said **Alexander Scudamore** from transferring or otherwise disposing of any movable or immovable property in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A(2) of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said **Alexander Scudamore** can continue to receive his salary which amount will not exceed thirteen thousand, nine hundred and seventy six Euro ((€13,976.00)).
