

**IT IS BEING NOTIFIED** that by a decree dated 30<sup>th</sup> June, 2010, given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dott. Claire L. Stafrace Zammit) Compilation Number 672/2010 in the names:

**ALFRED DELIA**, 65 years, pensioner, son of Emanuele and Maria Anna nee' Pisani, born in Zabbar on the 25<sup>th</sup> May, 1945 and residing at number 9, Casa Delia, Triq it-Telliera, Zabbar, holder of Identity Card number 459045(M); and

**MARCO DELIA**, 43 years, employed, son of Alfred and Catherine nee' Camilleri, born in Pieta' on the 14<sup>th</sup> July, 1966 and residing at number 9, Casa Delia, Triq it-Telliera, Zabbar, holder of Identity Card number 311466(M).

**ORDERED** the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Alfred Delia and Marco Delia** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the social benefits and also any subsidiary with regard to water and Electricity which the accused Alfred Delia receives will not be affected by this attachment order. With regard the accused Marco Delia, the court order that his salary of seven hundred Euro(€700) will not be effected by this attachment order.
