

IT IS BEING NOTIFIED that by a decree dated 3rd March, 2011 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dott. Giovanni Grixti) Compilation Number 370/2011 in the case:

Versus:

PASCHALINO CEFAL, 31 years, businessman, son of the late Joseph and Theresa nee' Saliba, born at Attard on the 13th December, 1979 and residing at 24, Triq il-Madonna tac-Cicri, Zebbug, Gozo and holder of Identity Card number 52480(M); and

GEORGE FRENDO, 45 years, son of Alfred and Carmela nee' Camilleri, born at Marsa on the 29th June, 1965 and residing at 36, Triq San Bartilmew, Zurrieq and/or 6, Rose Street, Zurrieq and holder of Identity Card number 361665M

ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Paschalino Cefai and/or George Frendo** and prohibits the said accused from transferring or otherwise disposing of any moveable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused **Paschalino Cefai** can withdraw the amount of thirteen thousand, nine hundred and seventy six Euro and forty nine cents ((€13,976.49) yearly for his living, as stipulated Law.

The Court ordered also that the social benefit which the accused **George Frendo** is receiving today from the Social Security is not affected from the freezing of assets.
