ANGELO ZAHRA, 65 years, pensioner, son of Joseph and Grazia nee' Zammit, born in Santa Venera Malta on the 29th August, 1949, residing at 'Shekinah', Bidnija Road, Bidnija Malta and holder of Identity card bearing number 751849(M).

AUTHORISED the accused **Angelo Zahra** to appear in his name and on behalf of his mandates on the deed of exchange with the Department of Lands so that he acquires the land in Marsascala as best described in the promise of sale dated 29 April 2014 so that finally there will be the payment of compensation from the government on the land which was expropriated on the 25th September 1987 and also **authorized** him to transfer and sell the land in his name and in the the name of its mandates under the promise of sale dated 29th April 2014 in the acts of Notary Charles Mangion and registered with number Ps 2014 04078 as subsequently amended in the acts dated 24 November 2014.
