SAM ZINA, 19 years, unemployed, son of Khalil Zina and Carmen Zina Dimech nee' Dimech, born in Pieta' Malta on the 12th August 1995, residing at Block E, Flat 23, Gilju Street, Zabbar Malta and holder of Maltese Identity Card bearing number 368195M.

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **SAM ZINA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

This publication is made following another publication published in the Government Gazette on the 27th January, 2015 where there is a correction in the sense that the Identity Card number of the accused **Sam Zina** should read 368195(M) instead of 168195(M).
