The freezing of assets was made in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta given by the Court of Magistrate (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Miriam Hayman LL.D.) on the 26th April 2007 and published in the Government Gazette on the 04th May, 2007 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Jason Cassar**.
