**Godfrey Gambin**, 38 years, son of Godfrey and Emanuela nee` Borg, born in Attard, on the 10th April 1976, residing at 1, Godlil, Trejjet ir-Rumanzieri, Iklin and holder of Identity Card bearing number 243176 M.

**AUTHORISED** the accused **Godfrey Gambin** to withdraw the amount of four thousand, nine hundred and twenty-six Euros and eighty-six cents (**€4,926.86**) from his bank account held at the Bank of Valletta plc (Gzira Branch) to pay the pending electricity bill.
