**ORDERED** the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **TONY CURMI** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

**AUTHORISED** that the accused can perceive the sum of thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24), provided that the Court must be informed by a note from which bank the amount will be perceived according to law.
