ACCEDED to the request of Maria Cassar Kruger (ID 140076M) in the sense that the Court authorized the accused **Angel Attard** to appear for the publication of a contract for the cancellation of a hypothec with number Vol. H. 8768/2005 after a contract of sale of movables dated 31st May 2005 in the records of Notary Rachel Busuttil between Maria Cassar Kruger and the accused **Angel Attard** and his then wife Karen Attard Valentine.
