

IT IS BEING NOTIFIED that by a decree dated 19th May, 2015 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Miriam Hayman LL.D.) after an application filed by Trevor Borg on the 27th February, 2015 Compilation number 946/2014 in the case:

TREVOR BORG, 30 years, unemployed, son of Saviour and Rita nee' Gatt, born in Pieta' Malta on the 1st October 1983, residing at 57, Fuq il-Verdala, Bormla Malta and holder of Maltese identity card bearing number 508983M;

AUTHORISED the accused **Trevor Borg** to withdraw the sum of ten thousand Euros (€10,000) from his bank account with Bank of Valletta which sum has to make part from the sum of thirteen thousand nine hundred and seventy-six Euros and twenty-four cents (€13,976.24) entitled to him per year for his living.

The freezing of assets was made in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta given by the Court of Magistrate (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Miriam Hayman LL.D.) on the 15th October, 2014 and published in the Government Gazette on the 21st October, 2014, following other decrees given by the same Court published on the 19th December, 2014 and on the 20th January, 2015 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Trevor Borg**.
