FESTUS KALU OKWARA, 33 years, employed, son of Mick and Ola, born in Cameroon on the 28th April 1982, residing at number 15, Saint Elena Flat 4, Kubrit Street, Gzira Malta and holder of Maltese Identity Card bearing number 46381A;

AND

CHARLES IKHELOA, 37 years, employed, son of Ikheloa and Mary, born in Nigeria on the 15th April 1978, residing at Fingest, Flat 104, Mons Innocenz Zammit, Msida Malta and holder of Maltese Identity Card bearing number 54044A.

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **FESTUS KALU OKWARA** and **CHARLES IKHELOA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, of Article 5 (1)(a)(b) of the prevention of Money Laundering Act, Chapter 373 as well as to issue orders as provided for in Articles 5(1) and 5(2) of the same Act and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

AUTHORISED that the two accused can receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
