

IT IS BEING NOTIFIED that by a decree dated 13th July, 2015 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Joseph Mifsud LL.D) Compilation number 135/2013 in the case:

Versus

PETER (KNOWN AS PIERRE) FALZON, 55 years, Notary, son of Frances and Carmelina nee' Muscat, born in Pieta' Malta on the 05th August 1960, residing at Number 2B, Landbridge Mansions, *Dawret il-Gzejjer*, Qawra Malta and holder of Maltese Identity Card bearing number 535060M;

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **PETER (KNOWN AS PIERRE) FALZON** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

AUTHORISED the accused to perceive the amount of thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) provided that the accused has to present a note by which inform the Court from which bank account this sum is being perceived according to law.

For clarity's sake it is hereby stated that the freezing order published on the 21st July 2015 against the same accused is a result of a different case bearing compilation number 144/2013.
