AND

JUSTINO JUNIOR ANGEL, 30 years, employed, son of Justino Sr. and Swinta nee' Pena, born in Aruba on the 02nd February 1985, without an address in Malta and holder of Dutch passport bearing number NM194B6D5.

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **BELKINS MILDRED MARQUEZ DEL TORO** and **JUSTINO JUNIOR ANGEL** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court **AUTHORIZED** the said accused to receive the amount that does not exceed thirteen thousand, nine hundred and seventy-six Euros and twenty-four cents (€13,976.24c) each per year.
