**AUTHORISED** the accused **Angelo Bilocca** to receive the sum of three thousand two hundred and twenty-four Euros and eighty-seven cents (€3,224.87) from the Agriculture Directorate and also **authorised** the bank which is going to receive this sum to pass it to the said **Angelo Bilocca**. Moreover the Court ordered that this sum will make part of the sum of thirteen thousand nine hundred and seventy-six Euros and twenty-four cents (€13,976.24) entitled to him per year for his living.

The freezing of assets was made in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and section 23A of the Criminal Code, Chapter 9 of the Laws of Malta given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Miriam Hayman LL.D.) on the 14<sup>th</sup> February, 2013 and published in the Government Gazette on the 19<sup>th</sup> February, 2013 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Angelo Bilocca and Priscilla Cassar**.
