

It is being notified that by a decree dated 12th May, 2015 given by the Court of Magistrates (Gozo) as a Court of Criminal Inquiry (Magistrate Dr Neville Camilleri LL.D.) Preliminary Investigation number 50/2015 in the case: The Police (Inspector Ian J. Abdilla and Inspector Rennie Stivala) versus **Anthony Debono**, 59 years of age, son of the late Emanuele and of Francesca née Muscat, born in Nadur, Gozo, on the 13th January, 1956 and residing at “Anna”, Triq il-Knisja, Nadur, Gozo, (Identity Card number 7856G), ordered the attachment in the hands of third parties in general all monies and other movable property due, or pertaining, or belonging to Anthony Debono, and prohibits the said accused from transferring, pledging, hypothecating, or otherwise disposing of any movable or immovable property in terms of Article 23A of Chapter 9 of Criminal Code of the Laws of Malta and Article 5(7) of Chapter 373. The Court, in terms of the *proviso* to Article 5 (1) (b) of Chapter 373 of the Laws of Malta, conceded the accused to receive the amount of €13,976.24c per annum.

Abdilla u l-Ispettur Rennie Stivala) kontra **Anthony Debono**, ta’ 59 sena, iben il-mejjet Emanuele u Francesca née Muscat, imwieled Nadur, Għawdex, nhar it-13 ta’ Jannar, 1956 u residenti Triq il-Knisja, Nadur, Għawdex, (Karta tal-Identita’ numru 7856G), ordnat is-sekwestru f’idejn terzi persuni b’mod ġenerali, il-flejjes u l-proprjetà mobbli kollha li jkunu dovuti lil jew ikunu jmissu lil akkuzat, jew li huma proprjetà tieghu, kif ukoll sabiex il-Qorti tipprobjixxi lill-akkuzat milli jittrasferixxi, jew xorta’ohra jiddisponi minn xi propjeta’ mobbli jew immobbli, u dan ai termini tal-artikolu 23A tal-Kodici Kriminali Kap. 9 tal-Ligijiet ta’ Malta u kif ukoll l-Artikolu 5(7) tal-Kapitolu 373 tal-Ligijiet ta’ Malta.
