Rel.), B.A. (Hons), M.A. (European) LL.D., Kumpilazzjoni numru 112/2013 fil-kawża fl-ismijiet: Il-Pulizija (Spettur Bernard Charles Spiteri) kontra **Jonathan Roger Portelli** ta' 34 sena, iben Roger u Antoinette née Debrincat, imwieled Rabat, Għawdex, nhar it-3 ta' Mejju 1982 u residenti 'Highfields', Triq ta' Luvier, Munxar, Għawdex (karta tal-identità numru 32782G), ordnat is-sekwestru f'idejn terzi persuni b'mod ġenerali, il-flejjes u l-proprjetà mobbli kollha li jkunu dovuti lil, jew ikunu jmissu lil Jonathan Roger Portelli, jew li jkunu proprjetà tiegħu, u pprojbiet lill-imsemmi akkużat milli jittrasferixxi, jagħti b'rahan, jipoteka, jew xort'oħra jiddisponi minn xi proprjetà mobbli jew immobbli ai termini tal-Artikolu 5 tal-Att kontra l-Money Laundering, Kap. 373 tal-Liġijiet ta' Malta, u tal-Artikolu 23A (2) tal-Kodiċi Kriminali, Kap. 9 tal-Liġijiet ta' Malta. Il-Qorti kkonċediet lill-imputat li jirċievi €13,976.24c fis-sena, u dan skont il-proviso tal-Artikolu 5 (1) (b) tal-Kap. 373 tal-Liġijiet ta' Malta. Reġistru tal-Qorti tal-Maġistrati (Għawdex) bhala Qorti ta' Gudikatura Kriminali, illum 2 ta' Ottubru, 2015.

It is being notified that by a decree dated 30th September, 2015 given by the Court of Magistrates (Gozo) as a Court of Criminal Inquiry (Magistrate Dr. Joseph Mifsud B.A. (Leg. & Int. Rel.), B.A. (Hons), M.A. (European), LL.D., Preliminary Investigation number 112/2013 in the case: The Police (Inspector Bernard Charles Spiteri) versus **Jonathan Roger Portelli**, 34 years of age, son of Roger and of Antoinette née Debrincat, born in Victoria, Gozo, on the 3rd May, 1982 and residing at 'Highfields', Ta' Luvier Street, Munxar, Gozo (identity card number 32782G), ordered the attachment in the hands of third parties in general all monies and other moveable property due, or pertaining, or belonging to Jonathan Roger Portelli, and prohibits the said accused from transferring, pledging, hypothecating, or otherwise disposing of any moveable or immovable property in terms of Article 5 of the Prevention of Money Laundering Act, Cap. 373 of the Laws of Malta, and Article 23A (2) of the Criminal Code, Cap. 9 of the Laws of Malta. The Court in terms of the proviso to Article 5 (1) (b) of Cap. 373 of the Laws of Malta conceded the accused to receive the amount of €13,976.24c per annum.
