

IT IS BEING NOTIFIED that by a decree dated 13th February, 2015 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Paul Coppini LL.D) Compilation Number 29/2015 in the case:

Versus:

FRANCIS XERRI, 53 years, Watchman, son of Eucharist and of Clementa nee' Camilleri, born in Victoria Gozo on the 20th January 1962, residing at Triq Qasam Ta' Dun Anton, Xaghra, Gozo and holder of Maltese Identity Card bearing number 5762(G).

ORDERED the attachment in the hands of third parties in general of all monies and other movable property due to or pertaining or belonging to **FRANCIS XERRI** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 5 of Chapter 373 of the Money Laundering Act of the Laws of Malta, in accordance with Article 23A (2) of Chapter 9 of the Laws of Malta.

AUTHORISED that the accused can withdraw the amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year that is one thousand, one hundred and sixty-four Euro and sixty cents (€1,164.60) per month from his bank account with Bank of Valletta plc.
