

IT IS BEING NOTIFIED that by a decree dated 11th March, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Natasha Galea Sciberras LL.D) Compilation Number 133/2016 in the case:

Versus:

KENRICK SCIRIHA, 28 years, unemployed, son of Francis and Pauline nee' Agius, born in Pieta' Malta on the 26th September 1987, residing at 'The Meadows', Flat 13, *Alka* Street, St. Paul's Bay Malta and holder of Maltese Identity Card bearing number 427087(M).

ORDERED the attachment in the hands of third parties in general of all monies and other movable property due to or pertaining or belonging to **KENRICK SCIRIHA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 22A of the Dangerous Drugs Act, Chapter 101 of the Laws of Malta and of Article 5 of Chapter 373 of the Money Laundering Act of the Laws of Malta, in accordance with Article 23A of Chapter 9 of the Laws of Malta.

The Court **AUTHORISED** that the accused **Kenrick Sciriha** can receive the amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year for his living.
