

## **DKR 137/2015 – VARIATION OF A FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 24<sup>th</sup> November, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Christian Caruana on the 22<sup>nd</sup> November, 2016 Compilation number 1095/2014 in the case:

**KRISTIJJAN ZEKIC**

**The Court AUTHORISED the accused Christian Caruana** to withdraw his stipend from his Bank of Valletta account bearing number 40022593050 which amount does not exceed thirteen thousand nine hundred and seventy-six Euros and twenty-four cents (€13,976.24) per year.

This variation is being published according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta following a freezing order dated 11<sup>th</sup> March, 2015 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Miriam Hayman LL.D) and published in the Government Gazette on the 25<sup>th</sup> March, 2015 where the Court ordered the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **CHRISTIAN CARUANA AND KRISTIJJAN ZEKIC**.
