

DKR 137/2016 – FREEZING OF ASSETS

IT IS BEING NOTIFIED that by a decree dated 24th March, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Josette Demicoli LL.D) Compilation Number 168/2016 in the case:

Versus:

SEAN FARRUGIA, 26 years, self-employed, son of George and Jane nee' Vella, born in Pieta' Malta on the 27th August 1989, residing at 'Springtide', Flat 1, Luigi Onofrio Street, Birkirkara and Flat 1, Calypso Court, Triq it-Tunagg, Mellieha, Malta and holder of Maltese Identity Card bearing number 389789(M).

ORDERED the attachment in the hands of third parties in general of all monies and other movable property due to or pertaining or belonging to **SEAN FARRUGIA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 22A of the Dangerous Drugs Act, Chapter 101 of the Laws of Malta in accordance with Article 23A of Chapter 9 of the Laws of Malta.

The Court AUTHORISED that the accused **Sean Farrugia** can receive the amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year as salary, wages, pension or social benefits.
