

## **DKR 140/2016 – VARIATION OF A FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 15<sup>th</sup> June, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Natasha Galea Sciberras LL.D) after an application filed by Renald Barbara on the 02<sup>nd</sup> June 2016, Compilation Number 112/2016 in the case:

Versus:

**RENALD BARBARA**, 35 years, unemployed, son of Paul and Vincenza nee' Fenech, born in Pieta' Malta on the 25<sup>th</sup> February 1981, residing at number 29, Republic Street, Rabat Malta and holder of Maltese Identity Card bearing number 129981(M).

**The Court AUTHORISED** the accused to receive any social benefits or pays in amounts that in total do not exceed thirteen thousand, nine hundred, seventy-six Euros and twenty-four cents (€13,976.24) per year and which amount is entitled to him for his living according to law.

This variation is made in terms of Article 22A of the Dangerous Drugs Act, Chapter 101 of the Laws of Malta and of Article 5 of Chapter 373 of the Money Laundering Act of the Laws of Malta, in accordance with Article 23A (2) of Chapter 9 of the Laws of Malta after a decree given by the Court of Magistrates (Malta) as a Court of Criminal Judicature (Magistrate Dr. Marse-Ann Farrugia LL.D.) on the 09<sup>th</sup> April, 2016 and published in the Government Gazette on the 15<sup>th</sup> April, 2016 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Renald Barbara**.
