ORDERED the attachment in the hands of third parties in general of all monies and other movable property due to or pertaining or belonging to **RENALD BARBARA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 22A of the Dangerous Drugs Act, Chapter 101 of the Laws of Malta and of Article 5 of Chapter 373 of the Money Laundering Act of the Laws of Malta, in accordance with Article 23A (2) of Chapter 9 of the Laws of Malta.
