PAUL FARRUGIA, 31 years, unemployed, son of Carmelo and Matilde nee' Apap, born in Pieta' Malta on the 22nd October 1983, residing at number 12, Barka, *Xilep Lane*, Xgħajra Malta and holder of Maltese Identity Card bearing number 540483M.

The Court AUTHORISED the release of the open boat named White Sand with registration number S 9809 in favour of Anthony Meachen (Identity Card number 313680M).

This variation is being published after another publication published in the Government Gazette on the 12th February 2016 after a decree given by the same Court on the 04th February 2016, following a freezing order dated 12th April, 2015 which was duly published in the Government Gazette on the 21st April, 2015 in terms of Section 22A of the Dangerous Drugs Ordinance , Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Paul Farrugia**.
