

IT IS BEING NOTIFIED that by a decree dated 05th February 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Judiciary – (Magistrate Dr. Joseph Mifsud LL.D) after an application filed by **Sharon Camilleri** on the 26th January 2016, Compilation number 524/2012 in the case:

The Court ACCEDED to the request of **Sharon Camilleri** in the sense that the Court authorized the accused to continue receiving the permissible annual sum of thirteen thousand nine hundred seventy six Euro and twenty four cents (€13,976.24). Besides the accused can withdraw the sum of two thousand, four hundred and ten Euros and eighty-three cents (€2,410.83) from the safety deposit box in Court under the authority of the same Honorable Court and in the presence of the following: The Registrar of Courts (Malta) or his representative, Representative of the Bank of Valletta Plc, and the Prosecutor Inspector Antonovich Muscat. The decree or any relative document for this should be inserted in the acts of these proceedings.

The publication of this order is being published in terms of Section 5 of the Prevention of Money Laundering Act Chapter 373 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following another publication made on the 25th November 2014 after a decree of the same Court on the 30th June 2014, following another publication made on the 18th May 2012 after a decree from the Court of Magistrates (Malta) as a Court of Criminal Inquiry on the 16th May 2012 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Sharon Camilleri** and Giuseppe Cutajar.
