

## **DKR 165/2016 – FREEZING OF ASSETS**

**IT IS BEING NOTIFIED** that by a decree dated 17<sup>th</sup> May, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) Compilation number 1289/2014 in the case:

Versus

**MATTHEW ZARB**, 28 years, unemployed, son of the late Vincent and Frances nee' Mifsud, born in Pieta' Malta on the 05<sup>th</sup> January 1988, residing at Ideal, Flat 4, Sir Ugo Mifsud Street, Ta' Xbiex Malta and holder of Maltese Identity Card bearing number 41788(M).

**ORDERED** the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **MATTHEW ZARB** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

**The Court AUTHORISED** the accused **Matthew Zarb** to annually receive the amount authorized by law which is thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) provided that any financial entity is ordered to present a note by which it informs the Court in which account or from which account these monies are being received. Otherwise the accused himself is to indicate to the Court from which account he is to receive the relative monies.
