

## **DKR 179/2016 – VARIATION OF A FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 17th August, 2016 and another decree dated 22nd August, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Nicholas Vella on the 11th July 2016, Compilation number 333/2016 in the case:

Versus

**NICHOLAS VELLA**, 30 years, unemployed, son of Emanuel and Rose Mary nee' Farrugia, born in Pieta' Malta on the 18<sup>th</sup> April 1986, residing at number 49, The Chimes, Patri A. Tonna Barthes Street, Pembroke Malta and holder of Maltese Identity Card bearing number 181486(M).

**The Court AUTHORISED the accused Nicholas Vella** to withdraw the amount of one thousand and seven hundred Euros (€1,700) exhibited in the acts of these procedures and **also** to access the garage number 7, Entrance 39, *Irmigġ* Street, Innsida to take back the tools therein.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following a freezing order which decree was given on the 29<sup>th</sup> June, 2016 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Monica Vella) and published in the Government Gazette on the 05<sup>th</sup> July, 2016 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Nicholas Vella**.
