

DKR 179/2016 – FREEZING OF ASSETS

IT IS BEING NOTIFIED that by a decree dated 29th June, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Monica Vella LL.D) Compilation number 333/2016 in the case:

Versus

NICHOLAS VELLA, 30 years, unemployed, son of Emanuel and Rose Mary nee' Farrugia, born in Pieta' Malta on the 18th April 1986, residing at number 49, The Chimes, Patri A. Tonna Barthes Street, Pembroke Malta and holder of Maltese Identity Card bearing number 181486(M).

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **NICHOLAS VELLA** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court AUTHORISED the accused **Nicholas Vella** to receive the amount of thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
