

## DKR 187/2013 VARIATION OF FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 26<sup>th</sup> April, 2016 given by the Criminal Court – (Mr. Justice Dr. Antonio Mizzi LL.D.) following an application filed by Mahmed Amber Mahmud Ali on the 21<sup>st</sup> March 2016, Compilation number 436/2013 in the case:

Versus:

**Mahmed Amber Mahmud Ali**, 50 years, in business, son of Ali Amber and Galea nee' Ben Otman, born in Tripoli, Libya on the 22<sup>nd</sup> December 1966, residing at number 18, *Id-Dura*, Flat 2, *Mikielang* Busuttill Street, Safi Malta and holder of Identity Card bearing number 0019426A and of Libyan Passport M585282.

**The Court AUTHORISED** the accused to receive any Social Benefits which he may be entitled to receive from the Government of Malta.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following a decree given on the 09<sup>th</sup> May, 2013 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry and published in the Government Gazette on the 14<sup>th</sup> May, 2013 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Mahmed Amber Mahmud Ali**.
