

DKR 224/2012 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 03rd May 2016, given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Neville Camilleri LLD) after an application filed by James Grima on the 27th April 2016, Compilation number 800/2012 in the case:-

Versus:

JAMES GRIMA, 41 years, builder, son of Nazzareno and Crucifissa nee' Camilleri, born in Pietà' Malta on the 6th May 1975, residing at number 7, Old Mill Court, Old Mill Street, Mosta Malta and holder of Maltese Identity Card bearing number 249875 (M).

The Court AUTHORISED the scrapping of the vehicle with registration number ABI-243 owned by the accused James Grima and ordered that within fifteen days from the date of this decree, the accused shall present a note in the acts of the proceedings with a document which confirms that this vehicle was scrapped.

This variation was made following a freezing order dated 06th August, 2012 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Doreen Clarke LL.D.) which was duly published in the Government Gazette on the 10th August, 2012 in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **James Grima**.
