

DKR 229/2009 CANCELLATION OF FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 21st April, 2016 given by the Criminal Court of Appeal (Mr. Justice Dr. David Scicluna) following an application filed by Emanuel Farrugia on the 08th April, 2016 and after judgement given by the same Court on the 17th February, 2016 (Appeal Number 347/2011) which judgement revoked that given on the 27th July, 2011 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Doreen Clarke LL.D) in the case:
