

DKR 237/2010 – VARIATION OF FREEZING ORDER

IT IS BEING NOTIFIED that by a decree given by the Criminal Court of Appeal (Mr. Justice Dr. Giovanni Grixti LL.D) on the 14th April 2016 after an application filed by Charlie Gauci on the 06th April 2016 in the names:

vs

CHARLIE GAUCI, 35 years, driver, son of Carmelo and Emanuela nee' Sciberras, born in Pieta' Malta on the 19th May 1980, residing at number 186, Flat 9, Republic Street, Valletta Malta and holder of Maltese Identity Card bearing number 262280(M).

The Court AUTHORISED the accused Charlie Gauci to cash his salary cheque issued by Gozo Channel Company Ltd. through Bank of Valletta.
