

DKR 240/2016 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 27th July, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Charmaine Galea LL.D) Compilation number 392/2016 in the case:

(Inspector Gabriel Micallef)

Versus

LUDWIG BORG, 33 years, Mechanic, son of Anthony and Emanuela nee' Gauci, born in Pieta' on the 24th August 1982, residing at *Ġesu Redentur*, *Għargħur* Street, Naxxar, Malta and holder of Maltese Identity Card bearing number 477682M.

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **LUDWIG BORG** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court **AUTHORISED** the accused to continue to receive the amount that does not exceed thirteen thousand, nine hundred and seventy-six Euros and twenty-four cents (€13,976.24) per year.
