ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **WAYNE SAID** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, of Section 5 (1) (a) (b) and 5 (2) of the Money Laundering Act, Chapter 373 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.
