

## DKR 304/2013 – VARIATION OF A FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 17<sup>th</sup> May, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – Magistrate Dr. Neville Camilleri L.L.D., after an application filed by Joseph Abela (ID 492162M) on the 16<sup>th</sup> March 2016, Compilation number 575/2013 in the case:

And

**Clayton Neal Camilleri.**

**The Court AUTHORISED** the contract of sale and transfer of the property 210, Two Gates Street, Senglea in favour of Manuel Abela by the accused **Grezzju Abela** who has 1/6 undivided share instead of the 1/10 as previously indicated in the promise of sale of the same property.

This variation was made following a freezing order dated 24<sup>th</sup> June, 2013 given by the same Court and published in the Government Gazette on the 28<sup>th</sup> June, 2013 in terms of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta and Article 5 of Chapter 373 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Grezzju Abela and Clayton Neal Camilleri.**
