

DKR 366/2016 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 01st November, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Donatella Frendo Dimech LL.D) Compilation number 576/2016 in the case:

(Inspector Frank Anthony Tabone)

Versus

ANGUS CAMENZULI, 20 years, unemployed, son of Sandra-Lee Camenzuli, born in Pieta' Malta on the 29th January 1996, residing at number 18, Blakers Court, Flat 3, Palm Street, Attard Malta and holder of Maltese Identity Card bearing number 80096(M).

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **ANGUS CAMENZULI** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court AUTHORISED the accused **Angus Camenzuli** to perceive annually the amount authorized by law which is thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) provided that every financial entity is ordered to present a note by which inform the Court in which account or from which account these money are perceived or the accused himself indicate to the Court from which account he is perceiving the money indicated.
