

DKR 38/2011 VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 19th July, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Walter Desira on 01st April, 2016 (Compilation number 433/2011) in the case:

Versus

WALTER DESIRA, 39 years, son of Carmelo and Rita nee' Cassar, born in Pieta' Malta on the 03rd May 1977, residing at number 190, Casa Theresa, *Kandlora* Street, Żebbuġ Malta and holder of Maltese Identity Card bearing number 237377M.

The Court **AUTHORISED** the accused **Walter Desira** to dispose of his vehicle Toyota with registration number TWP 002.

This variation was made following another decree given on the 28th June, 2012 given by the same Court and following a freezing order dated 20th March, 2011 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry which was duly published in the Government Gazette on the 25th March, 2011 in terms of Section 22A of the Dangerous Drugs Ordinance , Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in general all monies and other movable property belonging to **Walter Desira**.
