

DKR 76/2011 – CANCELLATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 24th November 2016, given by the Criminal Court (Malta) (Mrs Justice Edwina Grima LL.D) after an application filed by Jason Farrugia on the 18th November, 2016 and following the execution of what was ordered in the judgement dated 22nd July, 2016 given by the same Court (Admission Number 1/2016) in the case:

JASON FARRUGIA, 33 years, son of George and Salvina nee' Bajada, born in Pieta' Malta on the 10th September 1983 residing at Corradino Correctional Facility, Paola Malta and holder of Maltese Identity Card bearing number 465983(M).

ORDERED THE CANCELLATION of the freezing order of all the movable and immovable property of the said **JASON FARRUGIA** which order was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry by a decree dated 09th July, 2011 and published in the Government Gazette on the 15th July, 2011.
