

DKR 88/2009 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 13th May, 2016 given by the Court of Magistrates as a Court of Criminal Judicature (Magistrate Dr. Neville Camiller LL.D.) after an application filed by Joseph Grech on the 09th May 2016, Compilation Number 1110/2008 in the case:-

The Police

Versus:

NAZZARENO SIVE RENO GRECH, 61 years, son of Joseph and Mary Concetta nee' Bugeja, born in Cospicua Malta on the 08th August 1954, residing at number 114, Felice Street, Żabbar Malta and holder of Identity card bearing number 629254(M).

The Court **AUTHORISED** the accused **Nazzareno sive Reno Grech** to sell the property 151, Alley no 2, *Bicċieni* Street, Żabbar with the condition that the proceeds from this sale are to be deposited in a bank account affected by the freezing order, which bank account has to be indicated with a note presented in these acts after the relative sale.

This variation is being published in terms of Article 23A (1) (2) of the Criminal Code Chapter 9 of the Laws of Malta following a freezing order published in the Government Gazette on the 17th March, 2009 after a decree dated 13th March, 2009 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Lawrence Quintano LL.D.) whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Nazzareno sive Reno Grech**.
