**IT IS BEING NOTIFIED** that by a decree dated 07<sup>th</sup> November, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Brian Zammit on the 30<sup>th</sup> October 2017, Compilation number 543/2015 in the case:
