

DKR 133/2016 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 30th December, 2016 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Jurgen Sant on the 11th October 2016, Compilation number 56/2016 in the case:

Versus

JURGEN SANT, 23 years, employee, son of Herman and Mariella nee' Farrugia, born in Pieta' Malta on the 08th Mary 1992, residing at 'St. Mary', *Għar Bittija* Street, Dingli and holder of Maltese Identity Card bearing number 242692(M).

The Court AUTHORISED the accused **Jurgen Sant** to continue to pay his car loan with Bank of Valletta plc on account number 40020521752 for the sum of twenty thousand one hundred and forty-seven Euros and seventy-one cents (€20,147.71) in monthly payments.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta following a freezing order given on the 17th March, 2016 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Neville Camilleri LL.D) and published in the Government Gazette on the 22nd March, 2016 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Jurgen Sant**.
